

## **SUMMARY ANNUAL REPORT**

### **For MOHAWK ESV, INC. HEALTH CARE PLAN**

This is a summary of the annual report of the MOHAWK ESV, INC. HEALTH CARE PLAN, EIN 20-1880191, Plan No. 501, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

MOHAWK ESV, INC. has committed itself to pay certain self-funded Medical claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with HAWAII MEDICAL SERVICE ASSOCIATION, CIGNA HEALTH AND LIFE INSURANCE COMPANY AND AFFILIATES, UNUM LIFE INSURANCE COMPANY OF AMERICA, EVERNORTH BEHAVIORAL HEALTH, INC., AMERICAN UNITED LIFE INSURANCE COMPANY, CONTINENTAL AMERICAN INSURANCE COMPANY, PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, and METROPOLITAN LIFE INSURANCE COMPANY to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$22,156,756.
